A qualified assistive animal may enter the SKKY Hotel and be in the hotel rooms, but the animal(s) must be approved by the SKKY Hotel in advance. Once approved, you will be notified and the note will be added to your reservation. Failure to submit this form may result in the assistive animal(s) not being accommodated because of the concerns for our staff and other guests.

Animal Training

The service animal must be fully certified in writing as having been trained by a professional service animal institution or qualified individual. Proof of training must include an identification card or other document issued by an organization or person specializing in service animal training that identifies both the person with the disability and their service animal to show that:

- The service animal has been individually trained by that organization or person to perform a task or tasks to assist the person with a disability with a need related to their disability
- A clear description of the task(s) the animal has been trained to perform to assist the person with their disability-related need(s).
- The credentials of the trainer(s) including any qualifications, certifications and affiliations with professional service animal organizations such as Canadian Association of Service Dog Trainers.

Details about the training and institution/trainer are required as SKKY Hotel may need to confirm this information. **Registry information alone is insufficient as proof of training.** Please email proof of training documentation along with this form.
